Q1: "What is the approximate start date of these contracts?"

A: We estimate the contract to begin on April 1, 2024

Q2: "For Contract 1B – Sodium Hypochlorite, would the Township raise the minimum delivery amount to 1,000 gals?

A: As per the Technical Specifications, Instructions to Bidders, page IB item 3

With respect to Sodium Hypochlorite {Contract 1B}, the minimum delivery shall be 500 gallons.

Q3: "Please provide the last bid tabulations, current price being paid and current order history?"
