The COI must contain the following information:

- 1. In the box labeled Description of Operations, usually toward bottom of the form, it must say Marlboro Township is listed as additionally insured. It is best not to include mention of Marlboro Day or event date so COI can be used for additional events if applicable.
- 2. The box labeled **Certificate Holder**, usually located in the bottom left corner, it is required that the following is listed in the box, **Marlboro Township**, **1979 Township Road**, **Marlboro**, **NJ**, **07746**. **Please DO NOT use the Recreation name and address**.
